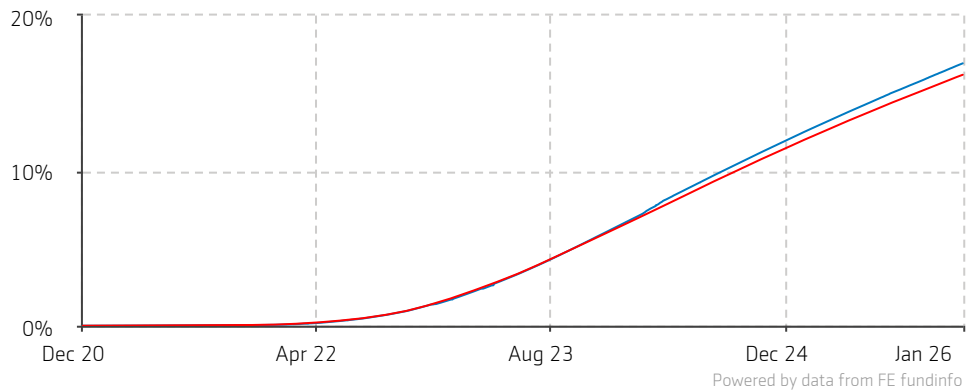
Fund objective

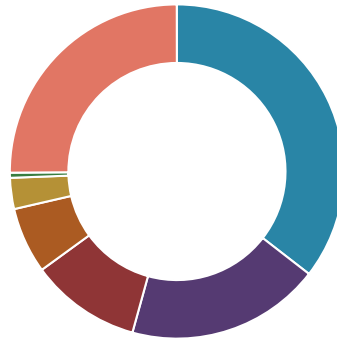
