

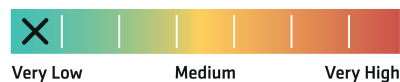

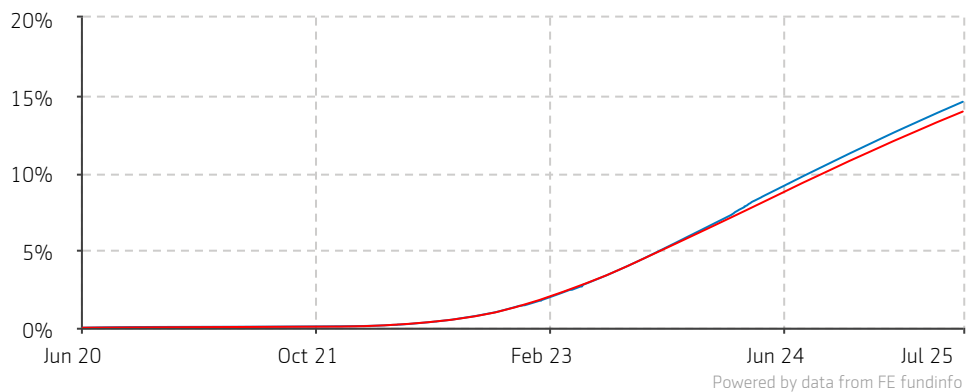
Fund objective

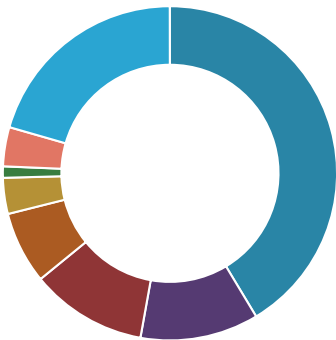
