### Fund objective

The fund aims to achieve capital growth and income which exceeds a composite benchmark of 30% MSCI All Country World Index with Developed Markets 100% Hedged to GBP and 70% Bloomberg Global Aggregate Index (GBP Hedged) (before charges) over a period of at least five consecutive years. The fund invests globally in any or all of the following asset classes: equities (company shares), fixed income securities (bonds), permitted money-market instruments (debt instruments with short-term maturities), permitted deposits, cash, other funds and derivatives. The fund may vary (without limit) the extent to which it invests in these asset classes, depending on market conditions and other factors at the fund manager's discretion.

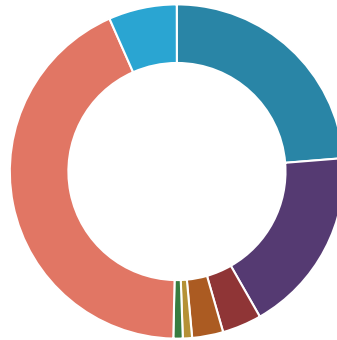
