Annual review of expenses TargetPlan and Aegon Master Trust (AMT) funds

June 2025

The list below shows all insured pension funds available via TargetPlan and Aegon Master Trust (AMT) affected by the 2025 annual review of expenses update.

What are additional expenses?

These are the costs of running the underlying fund over the last year. They include things like:

- Legal fees
- Auditor fees
- Administration fees
- Other operational expenses¹

They're on top of the scheme annual management charge (AMC).

Although we know the AMC in advance, we don't know what the day-to-day expenses will be as these change daily.

They are taken from the funds daily and the unit price shows this along with any gains or losses made. This is what determines the value of your policy. So regardless of the charges we show on fund factsheets and fund lists, you're charged the correct amount.

¹ Operational expenses can include costs paid by us (Aegon) to third parties.

How do we work out the additional expenses we show (disclose)?

Every year we contact all external fund managers to ask them to provide details of the additional expenses for each fund over the previous year. We then compare these with the expenses we disclosed the previous year and then round to the nearest 0.01%.

Where do we show (disclose) the additional expenses?

These are shown on our fund prices and performance pages, our fund factsheets and illustrations. These are the charges we disclose, which may differ slightly from the charges customers actually pay day-to-day as expenses fluctuate.

Old additional expenses – charge before the 2025 review of expenses.

New additional expenses— charge applied to the fund after the 2025 review of expenses.

Difference – the difference in the old and new additional expenses after the 2025 review of expenses.
