Update to additional expenses Pension and Life funds

March 2024

We regularly review the additional expenses for all our insured funds as part of our commitment to provide a clear indication of costs to our customers. As a result of our last annual review, we made changes to the additional expenses of some of our insured funds. We've carried out a further review of additional expenses, and so we'll be making further updates to the expenses for some of our insured funds. The list below shows all the funds impacted.

Additional expenses are on top of the annual management charge (AMC). <u>Together, they form part</u> of the 'Total Charge¹' for pension and life funds. We have no control over most of these expenses.

¹ This includes a standard 1% product charge, a fixed management fee and expenses that vary with day-to-day costs of running the fund. Investors may pay a different product charge, in which case the Total Charge will be different.

Please note that the total we show in the tables below excludes any product charge and all charges shown are as at March 2024, unless otherwise stated.

Key:

Mnemonic – Fund mnemonics are a three-letter code used by Aegon to identify its funds on internal systems.

Old total (underlying fund manager AMC plus additional expenses) – the underlying AMC plus additional expenses applied to the fund after 2023 review of expenses. This excludes any product charge.

New total (underlying fund manager AMC plus additional expenses) – the underlying AMC plus additional expenses applied to the fund after the further review of additional expenses in March 2024. This excludes any product charge.

Difference – the difference in the old and new total after the further review of expenses.
