How to top up an ISA or GIA

This guide explains how to top up an ISA or general investment account (GIA) on the Aegon Platform.

It can take up to seven working days to process your top-up request.

You can only complete this request online if you have transactional access.

If you have view only access to your account, you need to contact your financial adviser.





How to top up and ISA or GIA

- 1. Sign in to your Aegon Dashboard account.
- 2. Select the product you'd like to top up.
- 3. Then select **Top up**.

- 1. Before you begin, we'll set out what you need to do to complete your request.
- 2. Read over everything here and select **Start top up** to continue.



Select your payment method

- 1. Select Debit card, Cheque or Bank transfer.
- 2. Enter how much you want to top up by.
- 3. Confirm the **Source of wealth** from the drop down menu options.
- 4. If you're topping up your ISA, confirm the payment falls within your ISA annual allowance.
- 5. Select **Buy funds.**
