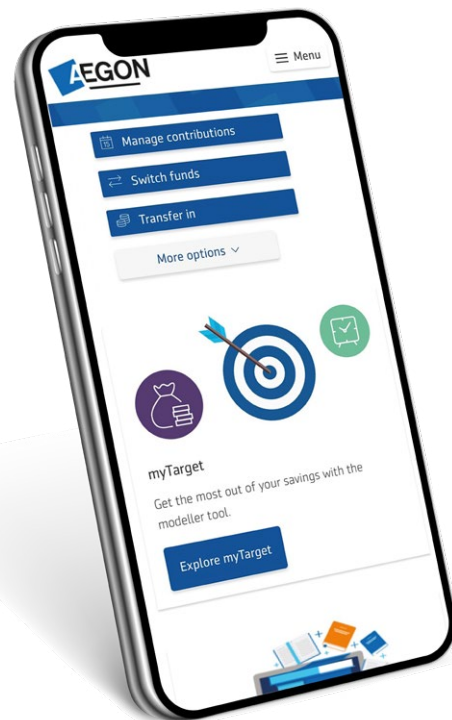
The annual charge on your new plan is made up of a service charge and an investment charge.
