

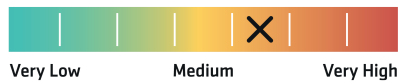

Fund objective

The fund aims to provide capital growth in excess of the MSCI All Countries World (Net Total Return) index (after charges) over any 3 to 5 year period by investing at least 80% of its assets in equities and equity related securities of companies worldwide with at least 70% classed as sustainable, based on the fund manager's sustainability criteria.

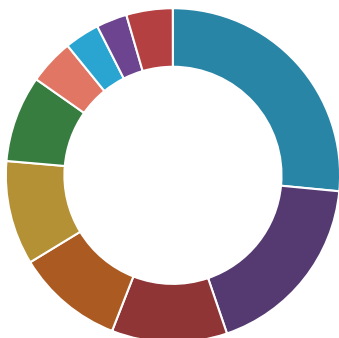

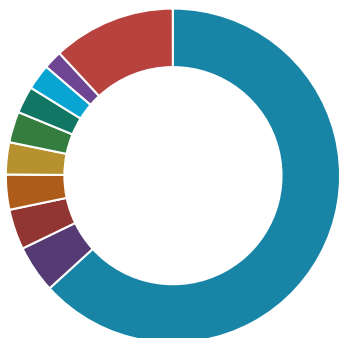
